Call for Artists at the Southwest Florida International Airport

July 2017-July 2018

A juried photography exhibit that portrays the amazing life beneath the waves and on the shores of Florida's coasts.

ELIGIBILITY & ENTRY FEE:

Open to all artists residing in Florida. Category is photography. An entry consists of 1 to 3 artworks. Non-refundable Entry Fee is \$15.00 for one entry and \$30.00 for 2 or 3 entries for Alliance for the Arts members - \$20.00 for one entry and \$40.00 for 2 or 3 entries for nonmembers. Alliance for the Arts memberships are \$55.00 and are good for one year.

Accepted imaging practices:

- Any type of camera can be used. All photographs should accurately reflect the subject matter and the scene as it appeared. Photos that have been digitally altered beyond standard optimization will be disqualified.
- *Acceptable*: adjustments to color, contrast, brightness and sharpness, removal of dust and scratches, cropping; black and white conversions. Stitching is acceptable.

SPECIFICATIONS

Medium: Photography, all photographs must be wired and framed with plexiglass and ready to hang and not to exceed 40 x 60 inches. **Size must be at least 36 x 48 and no larger than 40x60.**

LIABILITY

If artwork is juried in, artists are responsible for all shipping costs. Every effort will be made to handle with care, including protection from loss. Alliance for the Arts and Lee County Port Authority will not be liable for loss or damage caused or occurring while work is exhibited or during shipping. Submission of any artwork constitutes and agreement to all conditions of this entry form, including schedule and permission to photograph for publicity purposes. Signature on the entry form is an agreement to these conditions.
