We live in a rapidly changing world, from technology to our physical environments, it can feel daunting to try to keep up. For this exhibition, we ask artists to meditate on themes of change through a hopeful lens. Artists are asked to create work that explores ideas of growth, progress, and resilience. Artworks can represent the artist’s personal self-growth or images that relate to growth they see in the world around them. Artworks will feature traditional media such as painting and drawing but alternative approaches to mixed media or fiber arts are also encouraged.

ELIGIBILITY AND ENTRY FEE:

Open to all artists residing in Florida. An entry consists of 1 to 3 artworks. Non-refundable Entry Fee is \$25.00 plus a \$5 media fee for each artwork submitted. Alliance for the Arts members may use code Member10 to receive \$10 off their entry fee. Alliance for the Arts memberships are \$55.00 and are good for one year.

SPECIFICATIONS:

Medium: All 2-D mediums are acceptable including oil, acrylic, watercolor, mixed media, collage and photography. Only original artwork will be accepted, no giclee. All artwork must be at least 18x24 framed but not to exceed 40 inches in any direction. Gallery-wrapped canvas does not need to be framed. All artwork must be wired, ready to hang and delivered to the Alliance with the following information: Artist Name- Title – Medium – Price

LIABILITY

If artwork is juried in, artists are responsible for all shipping costs. Every effort will be made to handle with care, including protection from loss. Alliance for the Arts and Lee County Port Authority will not be liable for loss or damage caused or occurring while work is exhibited or during shipping. Submission of any artwork constitutes an agreement to all conditions of this entry form, including schedule and permission to photograph for publicity purposes. Signature on the entry form is an agreement to these conditions.
