



Alliance for the Arts - CALL FOR ENTRIES 38th Annual All Florida Juried Exhibition On Display: March 1- March 30, 2024

This annual show is the most anticipated of the year. As the name suggests, this exhibition features pieces created by artists working in a wide variety of media from all over the 65,000 square miles that make up Florida. The juried entries come together for an award-winning and exciting exhibition representing today's contemporary Florida artists. The exhibition will be on display March 1 – 30, 2024.

ELIGIBILITY & ENTRY FEE: Open to all artists residing in Florida. Only original artwork will be accepted, no giclee. Categories are, painting (including oil, acrylic, collage, watercolor and mixed media), drawing, photography, sculpture, ceramics, metalsmithing, glass, digital media, video, printmaking, fiber or textiles. An entry consists of 1 to 3 artworks. Non-refundable Entry Fee is \$25.00 for one entry and \$5 for each additional entry up to 3. Alliance for the Arts members may use coupon code **Member10** to receive \$10 off the entry fee.

Alliance for the Arts memberships are \$55 and are good for one year. You may sign up for membership [here](#).

Current students and teachers may use coupon code **Education10** for \$10 off the entry fee. To redeem this coupon, you must complete the application with a valid email address ending in .edu.

DEADLINE FOR ENTRY:

All entries must be submitted online no later than January 15, 2024 by 11:59pm. No materials will be accepted at the Alliance. Upload digital images of artwork in JPG or PNG format.

AWARDS- \$1000 cash for Best in Show, 2nd Place- \$300 Gift Certificate to Blick Art Materials, 3rd Place-\$150 cash, Jurors Choice Award-Artist Membership (\$75 value), American Art Collector Award of Excellence- One full page advertisement in American Art Collector Magazine

SPECIFICATIONS:

All 2D artwork must be wired and ready to hang and not exceed six feet in any direction. All 3D artwork must not exceed six feet in any direction or 150 lbs. All artwork must have been completed in the last two years and not previously shown at the Alliance. Artists are responsible for all shipping costs.

RETURN OF WORK:

Reasonable notice will be given to the Artist that the Work is to be removed at the end of the exhibition period. If the Artist is unable or unwilling to remove a Work within 30 days after notice to remove has been sent to them, the Alliance for the Arts agrees to make reasonable efforts to return the Work to the Artist. Reasonable effort will not require special shipping or handling procedures. If the Artist remains unavailable after a reasonable effort has been made, the Works will be donated to the Alliance.

LIABILITY

If artwork is juried in, artists are responsible for all shipping costs. Every effort will be made to handle with care, including protection from loss. Alliance for the Arts will not be liable for loss or damage caused or occurring while work is exhibited or during shipping. The Alliance reserves the right to photograph or otherwise reproduce the Works for marketing purposes only, both for the Exhibition and for future general marketing and publicity of the Alliance. *The Alliance will take reasonable steps to protect Artist's copyright at all times but the Artist understands and accepts the risk associated with marketing the Works on the Alliance's website and otherwise.*

Submission of any artwork constitutes an agreement to all conditions of this entry form, including schedule and permission to photograph for publicity purposes.

SALES

All submitted works selected for inclusion and display during this exhibition must be offered for sale to the public at a labeled price set by the artist. Entries submitted not for sale will be rejected. A 40% commission will be retained by the Alliance for the Arts on all work sold during the exhibition.
